### Why do young people sext?

Because they are curious about sex and curious about relationships. So to get to the route of sexting we need to do lots of work with young people around healthy relationships.

**Remember:** The production and distribution of sexting images involving anyone under the age of 18 is illegal and needs very careful management for all those involved



### What?! Porn is not real?

Recently a year 10 lad was shocked when I told him the vast majority of porn was not real, played out by actors and it can take hours to film scenes. **Recent research from the NSPCC highlights more than a third of 13-14 year olds who have seen online porn want to copy some of the behaviour they have seen.**

### Reinforce!

88% of images that go onto or through social media including Snapchat will end up on other websites without us realising. **Also the average time it takes to groom a young person online is 20 mins.**



### Sexting

In August UKCCIS brought out a fantastic document on how schools should be responding to sexting. The document highlights the term "sexting" is too woolly and goes on to define what sexting actually is. We need to move away from the term sexting and use 'youth produced sexual imagery'.
